Monthly Report to the City Council **Nov. 2025**

1. Last month (Oct 2025) we had 254 accounts. We had 113 active, 135, inactive, 7 "forfeitures" (a person who has moved away leaving an unpaid bill, but his Clarksdale residence is now occupied by another), including three unbilled (city hall, city park, ball park & Community Center). Bills were sent out for 111 accounts, the City Park used -0- gallons, the Ballpark used 80 gallons, Community Center used 13 gallons, City Hall used 42 gallons. Last month we used 443,800 gallons. Charges from PWSD #1 was \$1,916.86(bill received on (10/15/2025). We billed customers for 340,234 gallons. The fire dept reported 1000 gal. usage in Oct. Actual water loss of 102,566 gallons shows a total of -23.11% water that equals \$550.52
