Monthly Report to the City Council

## November 2024

1. Last month (Oct. 2024) we had 240 accounts. We had 110 active, 123, inactive, 7 "forfeitures" (a person who has moved away leaving an unpaid bill, but his Clarksdale residence is now occupied by another), including three unbilled (city hall, city park, & Community Center). Bills were sent out for 110 accounts, the **City Park** used -0- gallons, the **Community Center** used -0- gallons, **City Hall** used 421 gallons. Last month we used 397,700 gallons. Charges from PWSD #1 was \$1,631.11 (bill received on (10-17-2024). We billed customers for 353,660 gallons. The fire dept reported -0- gal. usage in Oct. Actual water loss of -44,040 gallons shows a total of -11.07% water that equals \$236.39
